As you may know, Virginia did not begin to keep birth records until 1853, so there will be no birth records either here or in Richmond for that period. Most generations are successfully connected by finding the wills and deeds in which the inheritance is recorded. As you can see, they were not in Kanawha County long enough to create those kind of records. You may have to continue to groom through the Gallia County, Ohio will and deed records to see if the connection is there. They really did not leave much of a trace here, compared to others – it is my feeling that they did not see themselves as permanent settlers here, but in transit. Permanent settlers appear as witnesses in each other's court cases. are appointed to maintain roads in their area, etc.

I hope you find the materials interesting. There were Lamberts in the Tazewell County book, but the pages exceeded what I could send you this time around. Please feel free to contact me if you have any other questions.
